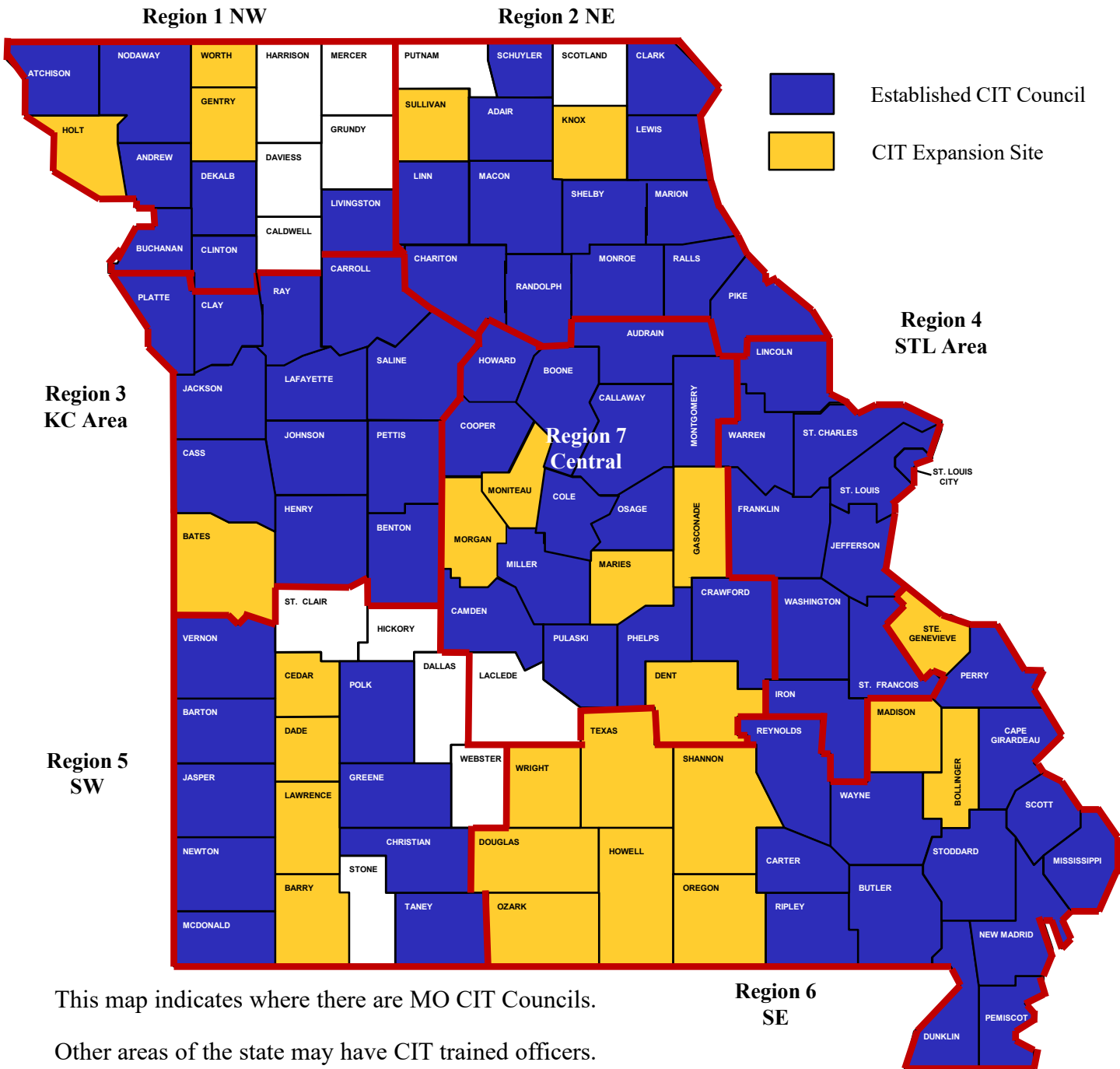


Missouri Crisis Intervention Team (MO CIT) Program Expansion Map July 2020
